

**SUSQUEHANNA ANNUAL CONFERENCE
OF THE UNITED METHODIST CHURCH
PEACE WITH JUSTICE GRANT APPLICATION GUIDELINES**

Purpose and Priorities for Funding

Financial grants are offered to agencies, local churches and community organizations located within the boundaries of the Susquehanna Annual Conference of the United Methodist Church seeking to minister in the areas of peace and justice. Projects addressing the following areas will receive higher priority: 1. Response to War and Root Causes of War, 2. Global and Local Disparity Between the Rich and the Poor, and 3. Interfaith and Community Coalitions for Peace and Justice. These grants may be made either to support ongoing programming or as “seed money” for new projects meeting needs not previously developed. Special consideration will be given to funding new projects.

Source of Funds

One half of all funds received by United Methodist churches within the Susquehanna Annual Conference from the annual Peace with Justice Sunday offering are allocated to the Susquehanna Annual Conference. These funds are used to provide grants for local projects in addition to providing training and resources to aid conference and local church Peace with Justice efforts. Peace with Justice Grants given out will not exceed \$1,000. to any one ministry.

Application Procedure

Grant applications may be submitted at any time with decisions to be made soon after applications are received. Applications, as received, will be distributed immediately to all members of the Peace with Justice Team for Review. Decisions on grant monies will be based off a majority decision of the PWJ Team.

Guidelines for Funding

There shall be a clearly demonstrated need. When appropriate, the grant proposal shall show evidence of long-range planning for the project with priorities, goals, realistic time line, and measurable objectives in evidence. The grant proposal should contain a detailed budget for the project and, if this is an ongoing project, the budget must contain plans for future funding. Funds granted by Peace with Justice do not necessarily commit the Team to ongoing funding of any project or activity. This limitation, however, does not preclude the Team from considering repeat applications from previously funded agencies, local churches and community organizations.
